



Memorandum of Understanding



This Memorandum of Understanding (MOU) is made on day of 1st September-23 between IEHE, BHOPAL and FPA INDIA, BHOPAL BRANCH.

Brief about FPA India- Family Planning Association of India (hereinafter referred as Second Party) is one of the largest NGO working in the country with its presence in all the States. The Association has been working in the field of Population Control, Women Empowering and health related issues. The Bhopal Branch also provides wide spectrum of quality services in the areas of Reproductive Health and Responsible Sexual behaviour to improve quality of life in Rural and Urban Slums. The Branch also works in the field of RCH, Family Welfare, Counselling, Women empowerment, Adolescent Health, Sexual Health, Safe Abortion, Terms of Orientation of Volunteers, Opinion Leaders and NGO staff.



IEHE, BHOPAL and FPA INDIA, BHOPAL BRANCH are individually referred to as the "Party" and collectively as the "Parties".

The terms and conditions of MoU are as follows:

1. IEHE will recognize FPA INDIA, BHOPAL BRANCH as an Institute for internship and practical exposure to their students.
2. Those IEHE Intern students who work in FPA INDIA, BHOPAL BRANCH will be governed by the relevant rules and regulations of FPA INDIA, BHOPAL BRANCH.
3. The approved FPA INDIA, BHOPAL BRANCH staff members may provide the research supervision. Any publications resulting from the thesis research will be processed jointly by the team of FPA INDIA, BHOPAL BRANCH and IEHE, BHOPAL.



4. Any IPR (Intellectual Property Right) that is process/know how/technology/design as research outcome shall be normally owned jointly by FPA INDIA, BHOPAL BRANCH and IEHE, BHOPAL unless mutually agreed otherwise. The outcome/benefit of the research work shall be the property of the party executing the experimental research work.
5. Any IPR generated in this MoU shall be protected by patents/copyright/design rules as applicable.
6. That the Director of First Party will depute persons who will work in close co-operation with FPAI Team for undertaking activities related to Health like paid Camp and sessions.
7. Family Planning Association of India, Bhopal Branch may provide paid health check-up services for teachers and students of IEHE, Bhopal. The duration of the health check-up services can be once in a month. Such activities we be conduct as per the charges, venue and time mutually agreed by both parties from time to time.
8. Any student carrying out dissertation/thesis work after permission granted by administration of FPA India Bhopal Branch, if found violating the rules and regulations laid by FPA INDIA, BHOPAL BRANCH or indulging such activities that amount to tarnishing the images of the Institute or IEHE, Bhopal damage to the property, will be summarily terminated on a written report by FPA INDIA, BHOPAL BRANCH. The IEHE will not complete the formalities of issuing the certificate to such students until matter is resolved with FPA INDIA, BHOPAL BRANCH.
9. FPA INDIA, BHOPAL BRANCH and IEHE, Bhopal may add, modify, amend or delete any part of this agreement by mutual consent and understanding of the signing authority from IEHE, Bhopal
10. The agreement will be effective for a period of **Three years i.e., 31st August-26** and can be renewed further with mutual consent. Either party may terminate the agreement by written notification signed by the appropriate

official of the Institute initiating the notice. Such notice may be received by the other parties 30 days prior to effective termination date. However, obligations and commitment already contracted for invoking the parities shall be honoured and continued by both parties until such commitments are completed."
