

## **ARTICLE-1: SCOPE OF THE MOU**


This MOU modalities and general conditions regarding collaboration between Institute for Excellence in Higher Education(IEHE), Bhopal and Government Girls College, Mandsaur for enhancing, in the areas of ACADEMIC DEVELOPMENT by mutual consent within the country, by maintaining prejudice to prevailing rules and regulations of Institute for Excellence in Higher Education(IEHE), Bhopal and Government Girls College, Mandsaur without any disregard any mechanism evolved and approved by the Competent Authorities under Govt. of India. The areas of cooperation can be extended through mutual consent.

## **ARTICLE II: SCOPE AND TERMS OF INTERACTIONS**

- a) Exchange of personnel through deputation as per the rules of the respective institute.
- b) Organization of joint conferences and seminars, student project thesis in

ACADEMIC DEVELOPMENT and other areas of national interest at Institute for Excellence in Higher Education(IEHE), Bhopal by Government Girls College, Mandsaur or vice versa on mutually agreeable terms. c) Government Girls College, Mandsaur would accommodate trainees of Skill Development Modules Diploma and UG students who have completed the pre final semester of their program Government Girls College, Mandsaur deems convenient to it for the purpose of imparting training.

d) Allow the industrial visits of students for half/full day to provide them exposure to various equipment instruments, etc at the Government Girls College, Mandsaur. or any other allotted authorised premises.

### **ARTICLE-III: SHARING OF FACILITIES**

a) Institute for Excellence in Higher Education (IEHE), Bhopal and Government Girls College, Mandsaur may depute its personnel as visiting faculty/ trainers at Institute for Excellence in Higher Education (IEHE), Bhopal to teach impart training on any the regular Course or specialized topics to promote academic and research interaction.

b) Institute for Excellence in Higher Education (IEHE), Bhopal and Government Girls College, Mandsaur shall permit the sharing of software and other materials and components developed in-house in the areas of cooperation, if permissible within the rules governing the two institutions. However, responsibility for safety of software and other materials during the exchange. **ARTICLE-IV: COORDINATION OF THE PROGRAMME INCLUDING FINANCIAL ARRANGEMENTS**

a) The collaborative Program between Institute for Excellence in Higher Education (IEHE), Bhopal and Government Girls College, Mandsaur shall be coordinated by an appointed coordination committee by the competent Authority of both the Institutes.

b) Wherever financial aspects are involved, amount, payment conditions, etc. would be spelt out clearly before starting the activity, decided based on different case-to- case. The financial proceedings must also be as per mutually agreed norms will brought on recording each case by approval from heads of both the Institutions.

### **ARTICLE-V: EFFECTIVE DATE AND DURATION OF MOU**


a) The duration of the MOU shall be for a period of 5 years from the effective date & may be enhanced or reduced based on mutually agreed terms & conditions.


b) During its tenancy, the MOU may be extended or terminated by a prior notice of not less than six months by either party. However, termination of the MOU will not in any manner affect the interests of the student/ faculty/scientists who have been admitted for pursuing a program under the MOU.

### **ARTICLE-VI: CONFIDENTIALITY**

During the tenure of the MOU both Institute for Excellence in Higher Education (IEHE), Bhopal and Government Girls College, Mandsaur shall place adequate and reasonable measures to keep and store confidential information secure to prevent from any unauthorized possession or knowledge of any confidential information not to disclose to third parties without written approval of the disclosing party or use such confidential information for any use other than intended under this agreement or PROJECTS.

CONFIDENTIAL INFORMATION means any proprietary information, data, or facts belonging to PARTIES collectively or severally, disclosed by the disclosing party under this agreement or any subsequent agreement, whether in writing, verbal or electronically, irrespective of the

medium in which such information is stored, whose information it is disclosed pursuant to court order or other legal compulsion, after providing prior notice to the disclosing party

#### ARTICLE -VII: AMENDMENTS

Any amendment and/or addenda to the AGREEMENT shall be in writing and signed by both the PARTIES hereto and shall only after such execution be deemed to form part of the AGREEMENT.





#### ARTICLE-VIII: RESOLUTION OF DISPUTES

a) The dispute or difference whatsoever arises between PARTIES in relation to or in connection with this AGREEMENT both the parties shall first try to resolve the dispute/difference amicably between themselves, failing which the matter shall be referred to and settled through arbitration. The arbitration proceedings shall be held in accordance with the provision of Indian Arbitration and Reconciliation ACT, 1996. The venue of arbitration shall be Bhopal and language of arbitration shall be English.

b) Both Institute for Excellence in Higher Education (IEHE), Bhopal and Government Girls College, Mandsaur shall not during the term of this Agreement directly or indirectly, solicit or offer employment or endangerment to any of the personnel of another party without the prior consent in writing of that other party.

c) After this Agreement has been signed all preceding understandings/negotiations and correspondence pertaining to it shall become null and void.
